Part II Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action On November 18, 2020, New Pacific Metals Corp. ("New Pacific") and its wholly-owned subsidiary, Whitehorse Gold Corp. ("Whitehorse"), engaged in a spin-out pursuant to a Canadian statutory plan of arrangement (the "Arrangement"). Specifically, in the Arrangement, New Pacific renamed and redesignated the New Pacific common shares ("Common Share") as Class A common shares ("Class A Share"), after which each New Pacific shareholder received one new New Pacific common share ("New Common Share") and 0.130707 Whitehorse common shares ("Spin-Out Share") in exchange for each Class A Share surrendered in exchange therefor pursuant to the Arrangement. Upon completion of the Arrangement, New Pacific shareholders held New Common Shares and Spin-Out Shares. No fractional shares were issued pursuant to the Arrangement, with any fractional shares rounded down to the nearest whole number. The Arrangement is described in the Management Information Circular of New Pacific dated August 27, 2020 (the "Circular"), which is on www.sedar.com. The information contained herein does not constitute tax advice and does not purport to be complete or to describe the consequences that might apply to particular categories of shareholders.

Though it is not free from doubt, New Pacific believes, that (a) the renaming and redesignation of the Common Shares as Class A Shares and (b) the exchange by the New Pacific shareholders of the Class A Shares for New Common Shares and Spin-Out Shares, taken together, will properly be treated for U.S. federal income tax purposes, under the step-transaction doctrine or otherwise, as (i) a tax-deferred exchange by the New Pacific shareholders of their Class A Shares for New Common Shares, either under Section 1036 or Section 368(a)(l)(E) of the Code, combined with (ii) a distribution of the Spin-Out Shares to the New Pacific Shareholders under Section 301 of the Code. As a result, and subject to certain passive foreign investment company ("PFIC") rules, New Pacific shareholders should have the same tax basis and holding period in such shareholder's New Common Shares as such shareholder had in its Class A Shares exchanged therefor pursuant to the Arrangement.

A shareholder that receives a distribution from New Pacific will be required to include the amount of such distribution in gross income as a dividend (without reduction for any Canadian income tax withheld from such distribution) to the extent of the current or accumulated "earnings and profits" of New Pacific, as computed for U.S. federal income tax purposes. New Pacific has not computed its current or accumulated earnings and profits under U.S. tax principles. As a result, shareholders may have to assume that the distribution of the Spin-Out Shares is ordinary dividend income equal to the fair market value of the Spin-Out Shares distributed. In addition, New Pacific expects that it was a Passive Foreign Investment Company ("PFIC") under Code Section 1297 for the tax year including the effective date of the Arrangement and believes that it was a PFIC in prior tax years. As a result, the distribution of the Spin-Out Shares from New Pacific will not constitute qualified dividend income eligible for the preferential tax rates applicable to long-term capital gains. The dividend rules are complex, and each shareholder should consult its own tax adviser regarding the application of such rules.

Shareholders should review the Circular and consult their own tax advisors regarding the U.S. federal income tax consequences of the Arrangement.
